

## Science and Technology Has Made Weather Forecasting More Predictable

The Mahoning Valley Chapter of the Military Officers Association of America met on Thursday, March 23, 2018 at the Consolidated Activities Center of the Youngstown Air Reserve Station in Vienna for a luncheon meeting. President Florence Hosler welcomed a guest, Father Steve Denas, whose son is serving in the Air Force. Lt Col Ralph Minton gave the invocation followed by the Pledge of Allegiance led by LTC Sam Axtell. LTC Rod Hosler provided a brief legislative update noting that President Trump signed the Omnibus bill. Although it did not provide everything the President had hoped for, it nevertheless gave the military a much-needed funding boost to shore up many shortfalls over the past 10 years. In addition LTC Hosler and Col Calta will again be “Storming the Hill” in Washington, DC meeting with Congressional legislators from Ohio from April 16<sup>th</sup> through 19<sup>th</sup>.

The guest speaker for the luncheon, introduced by COL John Koshan, was Ohio Air National Guard Captain, Joshua Palmer. Joshua, a local graduate of Mineral Ridge High School in 2008, was selected for the Air Force Academy and graduated in 2012 with a Bachelor of Science degree in Meteorology. After graduating the Air Force Academy, Capt Palmer was assigned to Little Rock Air Force Base in Arkansas as a Weather Flight Commander and Assistant Director of Operations. He is currently the Staff Weather Officer at Rickenbacker Air National Guard Base near Columbus, Ohio. He and his wife and two children live in Howland.

The science of analyzing weather and producing forecasts has come a long way from just adhering to the old adage, “Red sky in morning, sailors take warning. Red sky at night, sailors delight”. Weather conditions are a very important element in any commander’s assessment in conducting military operations. It is important to know not only what the current weather status is in the area of operations but what can be expected in the near term and next 7–10 days. Of course, there is greater uncertainty in predicting weather conditions the further you go into the future but cutting-edge science and

technology has made the process of forecasting a lot more predictable. There are essentially four different processes used to measure weather conditions. 1) Surface observations. 2) Upper air soundings. 3) Satellite imaging. 4) Radar readings. In surface observations a number of different instruments at fixed locations measure temperature, wind speed and direction, relative humidity, barometric air pressure, etc. Many of these same observations are recorded at various altitudes by using weather balloons. Weather satellites also use a multitude of instruments to record and transmit data back to earth from orbiting and geosynchronous satellites. And finally, Doppler radar can give a visual image of precipitation as it moves through an area. ### Membership Requirements for MSVC-MOAA

Membership in MSVC-MOAA shall be composed of: Men and women who are or have been commissioned or warrant officers of the seven United States uniformed services (Army, Navy, Air Force, Marine Corps, Coast Guard, National Oceanic and Atmospheric Administration, and Public Health Service). Surviving spouses of deceased individuals who, if living, would be eligible for membership. Chapter specific membership for spouses of present members and honorary members. MSVC-MOAA memberships are open to all eligible people.

**Legislative Issues – April 2018** *Legislative Affairs Liason, LTC Rod Hosler, USA, Ret.*

If you are a premium or life member of MOAA when you receive your April *Military Officer* magazine there are post cards on the back cover to be sent to your Senators and Representatives asking to support a pay increase that will keep military compensation comparable to private-sector compensation. **SEND IN THOSE POST-CARDS!** You can also e-mail your legislators through their web site, click the link on this page.

The President signed the \$1.3 trillion spending bill after a threat to veto because of the gains for the military and the VA to include:

- opioid abuse treatment and prevention;
- mental health programs, including mental health screenings and additional services for veterans with other-than-honorable discharges before leaving service, and suicide prevention outreach;
- research on gender-appropriate prosthetics and toxic exposure;
- development and implementation of the new electronic health record;
- efforts to reduce disability claims processing backlog;
- major and minor construction improvements; and,
- some portion of the FY 2019 appropriations for medical and benefit programs.
- A 2.4 percent pay raise for servicemembers, which they've been receiving since Jan. 1. (Learn more about the military pay-raise gap here.)
- \$700 billion for the military - the largest year-on-year funding increase for DoD in 15 years. That includes \$144 billion for weapons and equipment upgrades.
- A lift on defense spending caps, one of five things MOAA wanted President Trump to address in his first State of the Union speech.
- Spending flexibility that will allow military leaders to use some funds appropriated this year in fiscal 2019.
- A \$234 million funding increase for NOAA.
- Mental-health services for "bad paper" veterans that includes screenings before they leave the military. Metal-health support will also be provided to those who: served 100+ days on active duty, experienced sexual trauma, or served as drone operators.

But the Caring for Veterans Act failed as members of congress and VSO's were concerned it was moving the VA towards privatization and taking funds for infrastructure improvements.

Then Trump fired Secretary Shulkin so it's back to square one. It is hoped that after the congressional break for campaigning all parties to include MOAA will get back to the table and work this out.

There are several issues in the Veteran/Military Pending Ohio Legislature that affect the military and veterans:

**Students in Military:** To enact the "Students to Soldiers Support Act" regarding the participation of students who are serving in the uniformed services in extracurricular activities at public and non public schools and public and private colleges.

**Professional Licensure-Armed Forces:** To establish an expedited process to grant a professional license to an individual who is on active duty as a member of the armed forces of the United States, or is the spouse of such an individual, and holds a valid license in another state.

**Military Transfers:** To permit persons who quit work to accompany the person's military spouse on a military transfer to be eligible for unemployment compensation benefits.

**Veteran Commissions:** permit county veterans service commissions to elect to add two members to the commission, one who is a veteran who served in Operation Enduring Freedom or Operation Iraqi Freedom, or subsequently in those theaters of operation, and one who is a military spouse.

**Awareness Day:** To designate the first Saturday of May as "Veterans Suicide Awareness Day."

**Veteran Treatment:** To permit courts to create veterans treatment courts and to allow courts to divert certain criminal defendants to participate in veterans treatment court.

**Dog Registrations:** To exempt certain disabled veterans from paying a dog registration fee when application is made to the county auditor that includes proof that the dog is an assistance dog.

**Veterans Waiver:** To establish the Veterans Fee Waiver Program.

## Changes Coming to TRICARE Dental and Vision Insurance Coverage in 2019<sup>®</sup>

Starting in 2019, military retirees will have dental and vision coverage outside of TRICARE, while active-duty families will have access to vision coverage for the first time ever, thanks to a law passed by Congress in 2018.

### New Dental Insurance Plan

In 2019, the TRICARE Retiree Dental Plan is going away. Those covered under that plan who wish to keep coverage will be required to sign up for the Federal Employees Dental and Vision Insurance Program (FEDVIP), which is the same program used by civil service members and retirees.

The new dental plan will offer coverage options from 10 insurers, with each providing at least two different levels of coverage: standard and high. The high level typically offers a greater range of services and lower co-pay amounts than the standard version, but comes with a higher monthly cost.

Under both the current TRDP and the upcoming FEDVIP, monthly premiums are based on location. The premiums for both TRDP and FEDVIP are similar, so users may not experience a price jump, depending on the plan they choose.

For example, someone getting family coverage in Zone E, which is made up of 27 states, pays \$115 each month under the current TRDP, while the same person using FEDVIP would pay between \$60 and \$175 each month, depending on the insurance plan they choose.

Compared to TRDP, the new plans will offer a greater choice of dentists and more coverage options that retirees can tailor to their specific needs.

### New Vision Insurance Plan

Even bigger news is that in 2019 most retirees and active-duty family members will be newly eligible to enroll in the FEDVIP vision insurance program.

Vision coverage is currently not part of the TRICARE program. While beneficiaries now receive one free standard eye exam each year or every other year, depending on their plan and whether they are diabetic, exams for contacts are not covered, nor are glasses or contacts themselves.

But under the FEDVIP vision program, you will not only have a covered eye exam but, depending on your choice of coverage, you may be able to get glasses, contacts or both for free or a very deep discount. TRICARE will continue its current eye exam coverage system for those who do not enroll in the new vision plan.

Currently, there are four different insurers available in the FEDVIP vision program. Monthly family premiums range from \$19 to \$43.

Like the FEDVIP dental program, you will be able to choose from a greater number of eye care providers than are currently a part of the TRICARE networks, and tailor your coverage to fit your individual needs.

### Enrollment Information

If you are currently enrolled in TRDP, you will have to enroll in a FEDVIP dental plan during open season or you will lose your dental insurance in 2019.

If you want to enroll in the FEDVIP vision plan, you must also do it during open season. This year's open season runs from Nov. 12, 2018, through Dec. 10, 2018. You can make changes to your insurance each year during open season or when you experience a "qualifying life event" such as a job change, move or birth of a child.

While the enrollment period may seem like a long way off, if you are thinking about enrolling in either of these programs, it is probably a good idea to check them out ahead of time. The large number of plans and options can be pretty confusing.

If you plan on getting major dental work done, doing your homework can possibly save you a bunch of money. The new plan may be a lot cheaper than the current one, or vice versa.

Also, if you have kids who need braces, some insurance plans under FEDVIP require you to be enrolled for 12 months before insurance will pay for orthodontic care.

## Veterans Waiting for Their New ID Card to Arrive by Mail Sometime in April

Veterans waiting for their new ID card to arrive by mail won't see it until at least April, officials announced.

The free ID cards, available to honorably discharged veterans of all eras through the Department of Veterans Affairs website, were to be mailed in early March, VA officials told Military.com in January.

An email update sent March 13, however, announced that "printing and mailing for approved ID cards will begin in April."

The printing delay was caused by the review process, which must "ensure that a valid form of identification and image was provided," Curt Cashour, a VA spokesman, said in an email.

"VA is currently working with a print vendor to validate printed ID card samples, and we expect to complete this process soon so approved cards can be printed and mailed as soon as possible," he wrote.

Cards can also be downloaded and printed from Vets.gov. Almost 65,000 veterans had applied for the card as of March 13, Cashour said — about 50,000 new applications since late January.

The shipping delay is the latest in a series of errors since the cards' original rollout in late November.

The online application appeared to face major technical problems immediately after opening, and the VA in early December suspended new applications, instead posting a message asking veterans to submit an email address to receive updates. Applications opened again in late January.

The card program, which was ordered by Congress in 2015, is meant to give veterans a way to show proof of service to businesses and others without carrying their DD-214 discharge paperwork. It is not meant to replace other forms of military or veteran ID and does not serve as proof of qualification for any federal program. Veterans are not required to get the ID.

Veterans continue to encounter errors while applying for the card, according to feedback sent by veterans to Military.com. Some vets reported problems with the system accepting their service records, while others who reached out to VA officials for support were met with confusion.

"I even called President Trump's hotline for veterans and they forwarded my concern to a Dr. David J. Shulkin, the Secretary of the VA," one veteran wrote this week in an email to Military.com. "I heard back from a person in the VA and he told me that they have nothing to do with the new identification cards. They only deal with the identification cards for veterans that are getting medical coverage through the VA."
