MSVC-MOAA September 2025 Legislative SitRep From Your Liaison – Reporting for Duty

1. Social Security Fairness Act – Mission Accomplished

The campaign against the Windfall Elimination Provision (WEP) and Government Pension Offset (GPO) is over.

• Signed into law: Jan 5, 2025

Effective: Retroactive to Jan 2024

• **Payments:** Retro checks rolled out starting Feb; monthly adjustments began April. By July, SSA had cut 3.1 million payments worth \$17 billion, five months ahead of schedule.

Translation: Retirees, teachers, and first responders are finally getting their *full Social Security benefits*. Raise a glass—it's not every day Uncle Sam pays you back early.

2. TRICARE Fees - Hold the Line

Rumors of TRICARE hikes continue to float around Capitol Hill like stale chow-hall coffee.

- Status: No new increases yet
- **MOAA position:** Don't raid our wallets while the Pentagon funds another "study on studying studies."

3. Concurrent Receipt - Still on Patrol

Disabled retirees are still losing part of their retirement pay if they also receive VA compensation.

That's like being told you can't wear boots and socks at the same time because it's "double dipping." MOAA is pressing until concurrent receipt is standard issue for all.

4. NDAA Amendment Blitz – Eyes Sharp, Pens Sharper

Congress is back, and the FY26 National Defense Authorization Act (NDAA) has turned into a monster—with 1,500+ proposed amendments under review.

- **Hot targets:** Fixing pay for combat-injured veterans and improving access to care at military treatment facilities
- Why it matters: These amendments strike at our most critical flanks—quality of life and access to earned care
- MOAA call: Stay alert, contact your lawmakers, and remind them this isn't pork—it's payback for service rendered

Writing Your Legacy

As spouses and survivors of those who have served and defended our freedoms and our country, we play a vital role. We have very interesting and unique stories to tell.

Sharing your legacy – telling your story – will contribute to a more realistic narrative about life in the military and what it means to be a military spouse. It will better describe the roles we as military spouses and survivors have played. We have demonstrated leadership, strength, flexibility, dependability, and determination.

Over the years, whether our spouse was on active duty or retired, we have worked alongside, in front, and behind. We are often recognized as the unsung heroes of the military establishment.

Sharing Your Story

How do you begin to write about your legacy? First, decide how you want to tell your story: It can be an essay, a video, a recording, a letter, a blog, or a combination of different methods.

Next, decide on your audience: Family? Friends? Colleagues? Community? Of course, you can always produce several versions, depending on your audience and method.

Our stories – our legacy – can demonstrate the unique experiences and challenges we faced when married to a servicemember. These stories provide a personal perspective on military life as we know it. They showcase the many challenges of frequent moves, deployments, and how it all can affect our families, especially our children.

When writing your story, share the experiences that will educate your readers and create understanding about the different challenges you encountered. Share lessons learned along with any failures ... and successes! Also share stories about special relationships, the numerous moves and major choices you made. Your stories will be celebrated, cherished, and appreciated by your family, friends, and colleagues.

Many stories will turn out to be shared experiences. I travel a lot and talk to MOAA chapters and other military-associated groups where I always tell my story. As I talk about the frequent moves, my constant job changes, making furniture fit, the quarters assigned, and the undesirable locations, I always see a lot of heads nodding "Yes, I know!" right along with me.

And then I hear from other military spouses and survivors – different stories, unique experiences, and outcomes with lessons to be learned.

During the military life we have shared with our spouses, we have demonstrated dedication, unwavering support, resilience, sacrifice, solidarity, and courage through many deployments and relocations. Make your story real: Write about what happened and when, and how your feelings are associated with specific events and milestones. Your story has the power to inspire, connect, and endure.

March 1967 in Laos. His remains were never recovered. Army Private First Class John W. Alkire of Missoula Montana, fought on Bataan in the Philippines in 1942, was captured and survived the Bataan Death March; but died in POW Camp Cabanatuan on 7 July 1942. He was buried in a mass grave, and his remains are unidentified and listed as unaccounted (missing in action). He was my Mother's cousin. As of 2025, approximately 81,000 to 82,000 American service members from World War II, the Korean War, the Vietnam War, Cold War, and other conflicts remain unaccounted for. The majority are from World War II. Keep them and their families in your thoughts and prayers.

Finally, as we approach the end of the year it is that time when we elect new chapter officers. As always we need the support of our membership to sustain the leadership of the chapter. All organizations need "new blood" in order to thrive. Our chapter is no different. The Toledo Chapter closed because no one stepped forward to lead. Several other chapters are experiencing similar difficulties. Don't let our chapter go the way of the Dodo. Please consider becoming a chapter officer or board of directors member. We have all learned and practiced leadership from our military service and civilian endeavors. Your MOAA Chapter can use your expertise. CHAPTER MEMBER RECEIVES YSU CINCINNATUS AWARD

MSVC Chapter member James "Jim" Fairbanks has received the coveted "Cincinnatus Award" from Youngstown State University. The Office of Veterans Affairs at YSU annually recognizes an individual who has carried the spirit of his or her military service into their community by the contribution of their time and talents. This award honors an individual who has served their nation and returned to civilian life to continue the spirit of service by working or volunteering in areas such as public education, veterans' organizations and other community endeavors and projects. The award is named for Lucius Quinctius Cincinnatus, a military leader from Rome that served the republic as a soldier and senator. After retirement he was twice called upon to defend Rome and twice he saved Rome. He was offered the title "Dictator of Rome," and twice he refused and returned to his farm, and retired. Jim Fairbanks resides in Hubbard with his wife Jeanne and was a founding member of our chapter. Well done Jim.
