Legislative Issues – June 2014

Legislative Affairs Chair, COL John Koshan

Both houses of Congress continued their review and mark up of the 2015 Defense Authorization Bill during the month of May. MOAA has played a role in providing information to the various hearings. MOAA's position is and has been to **Sustain Pay and Benefits**,

position is and has been to Sustain Pay and Benefits, Reject TRICARE Fees, and to Eliminate Sequestration

The House of Representative passed their version of the 2015 National Defense Authorization Bill. This bill would set policy goals and spending targets for the fiscal year beginning October 1, 2014. The bill would provide a 1.8% pay increase and rejects Department of Defense's proposals to curb personnel costs by reducing housing, commissary and TRICARE costs. This action was taken by the House despite a veto threat by the White House and major areas of disagreement with the Senate.

Meanwhile the Senate is amending and or marking up its version of the legislation. The Senate Armed Services Committee has rejected the Pentagon's plan to cut commissary benefits and overhaul the TRICARE system. The Senate, however, did approve a 1% Cap on active duty pay raises. This is below the 1.8% increase that current law requires. The Senate also approved an increase for out-of-pocket housing costs for Military families and increases to pharmacy co-pays for prescriptions filled out of military treatment facilities. These proposals, considered short-sighted by MOAA, must be approved by the whole Senate. Whatever the final product coming from the Senate is, must be reconciled with the version passed by the House. The reconciliation process should prove to be quite contentious.

MOAA believes that the senate proposals reverse much of the hard work and progress Congress had made between 2000 and 2010. MOAA's position basically supports the House bill and encourages all members to contact our lawmakers asking them to resist these short-sighted cuts. As noted in last month's update, tough choices loom on the horizon via the Budget Control Act of 2011, known as **SEQUESTRATION.** More than a \$1 trillion in defense cuts are scheduled to occur between now and 2021. Continued movement towards Sequestration levels will result in readiness and modernization challenges, creating a "**Hollow Force**" and significantly affect National Security.

Again, members are asked to contact their representatives concerning both Sequestration and the Defense Bill for 2015.

In the Limelight: Col Dick Calta, USAF, Ret.

Col. Dick Calta, USAF (Ret), is a go-to leader in MOAA's council and chapter system. Calta, a Life Member, joined national MOAA in 1995. Five years later, he decided to see what the association's affiliates offered and joined the Orange County (Calif.) Chapter, where he served on the board of directors.



"I joined a chapter so I could continue to support national defense and veterans," says Calta. "I also missed the camaraderie and wanted to get more involved in the community."

In 2008, Calta relocated to Akron, Ohio, and joined the Ohio Western Reserve Chapter (OWRC). Within a year, he was elected president and went on to serve as the chapter's trustee, newsletter editor, and ROTC/Junior ROTC (JROTC) chair. Currently, he's the first vice president and publicity chair.

Calta, who is no stranger to volunteering in the community at events like the Akron Stand Down and the Adopt-a-Flag program, helped reenergize the OWRC by getting members involved in community-service projects. Members began supporting Honor Flight and providing financial support and volunteering at Valor Home in Akron, a 30-bed transitional housing facility for veterans.

The OWRC also formed a scholarship fund. Members award three \$500 scholarships annually to cadets in each of the three ROTC programs. Now they're planning to expand the program to include college-bound cadets in JROTC programs the chapter supports. Calta also is working with OWRC President Maj. Gen. Daniel Hahn, USA (Ret), and other chapter leaders to increase membership through MOAA's Chapter Recruiting 2014 program.

"I couldn't accomplish anything without the help of others," says Calta.

In 2011, leaders in the Ohio Council of Chapters asked Calta to serve as the new chapter development chair. He soon began working with Capt. George Williams, USN (Ret); Col. Walt Duzzny, USAR (Ret); LTC Don Rasile, USAR (Ret), LT John Holzer USN, and the late CWO3 Don Oglesby, USCG, and his wife, Janet, to form a new chapter that would serve members in the Youngstown, Ohio, Sharon, Pennsylvania area.

Less than a year later, Calta helped charter MOAA's Mahoning and Shenango Valleys Chapter (MSVC), where he served as secretary-treasurer and later as a board member. Calta continues to be an active member of the MSVC, driving 120 miles to attend monthly meetings.

"Having been a part of establishing a new chapter and growing the MOAA movement in Ohio is one of my proudest accomplishments," he says.

Calta also worked with leaders in the Ohio Council of Chapters to form the Mohican Satellite. The satellite, which has about 25 members, is attached to the Central Ohio Chapter in Columbus.

In September 2013, Calta received a MOAA coin for his superior leadership in helping organize and host the Ohio Council of Chapters' Convention. Calta used the event as an opportunity to get OWRC members more involved and interested in national MOAA and the chapter.

Calta spends about 40 hours a month working on council and chapter business. Those hours likely will increase once he finds his next challenge.

"I want to continue to help both the OWRC and MSVC grow in membership and influence," says Calta. "There is a lot of work to be done for our military members and veterans and their families."
