## What an Honor to Host Junior Cadets, a New Officer, Their Families and Instructors in May

The monthly membership dinner meeting at the Consolidated Activity Center at the Youngstown Air Reserve Station on May 28<sup>th</sup> proved to be an overwhelming success as our



Chapter honored three young Cadets and a newly commissioned Second Lieutenant. With our largest dinner gathering to date, 53 members and guests enjoyed a scrumptious meal of London broil, stuffed chicken breasts, twice baked potato, and mixed vegetables following an inspirational invocation by our Chaplain, Lt.Col Ralph Minton.

President Rod Hosler acted as the Master of Ceremony in the absence of our guest speaker, CPT Stephanie Crawford, USA, a Military Science Professor at YSU who was called away for a family medical emergency.

LTC Hosler is very knowledgeable of both the JROTC program at the high school level and the ROTC program at the college level having served as the Senior Army Instructor at Rayen High School for two years and as the Assistant Professor of Military Science at Youngstown State University for five years. The high-water mark for ROTC programs throughout the nation occurred in 1986 when over 400 ROTC programs were flourishing on our nation's colleges and universities. Though greatly diminished, there are still about 35,000 cadets training to receive their gold bars. Almost 40% are women. Hosler noted that the ROTC program at YSU was started in 1952 and that our Chapter membership has quite a few YSU Alumni. ROTC cadets have the opportunity to attend a 4-week Active Duty training tour at any number of CONUS and overseas bases throughout the world. Cadets can also choose to be enrolled in the SMP (Simultaneous Membership Program) and attend monthly drills with a Reserve unit.

Before the introduction of our guest Cadets, Janet Oglesby was presented with an Achievement Certificate from MOAA National for having the best newsletter of all Category V Chapters (fewer than 120 Members) in the nation. In the eyes of a panel of judges, the Mahoning and Shenango Valleys Chapter (editor – Janet Oglesby) won the Col. Marvin J. Harris Communications Award for several reasons: it covers chapter members' contributions in the community, it provides



an easy-to-use form to join the chapter or renew membership, it uses a good mix of copy, images, and white space, which creates an appealing, easy to read layout, and it is a monthly publication that is appealing to many different member demographics. Likewise, COL John Koshan, USAR, (Ret) won the Category V Harris Communications Award for best legislative coverage in print newsletters and also receive a framed certificate from MOAA National.



MSG Douglas Moon, Senior Army Instructor, introduced Cadet 2LT Marvinia Fulks, a sophomore at East High School who is one of the outstanding JROTC Cadet leaders of her class. MSG Moon explained that the Junior ROTC Program moved from Rayen High School to East High School.



John Miller introduced Cadet Autumn Hensley, a senior at Trumbull Career and Technical Center as the top recipient in a class of 75 for the MOAA JROTC Medal. Cadet Hensley will be joining her brother in the Marine Corps upon graduation from TCTC.



LTC Hosler introduced recently commissioned officer, 2LT Jared L. Hideg, FA, who was presented with a signed certificate and set of Gold Bars from MOAA National. 2LT Hideg, who will start his Officer Basic Branch Training at Fort Sill in September, offered a few nuggets of wisdom and tribute. "My parents shaped me to be the man I've become. CPT Crawford shaped me into the Officer I've become." His leadership philosophy basically entails the motto, "You are not right until the person next to you is right." Upon closing Hideg profusely thanked all the officers present because he would not be here today were it not for all those here who paved the path before him. He married his wife, Kristen, last November.

## Legislative Issues – June 2015

Congress has been busy working to fulfill its budgeting responsibilities since our last published update. The House has passed its version of the **FY 2016 Defense Bill**, while in the Senate, the Armed Services Committee has completed marking up its version of the Defense Bill. The two Bills show major divides on issues that we will cover in this update. Both Bills have utilized the input from the Administration and from the Committee to Modernize Military Compensation and Retirement. In their versions of the Defense Bill each body **skirted** the issue of **Mandatory Spending or SEQUESTRATION** by channeling monies to an emergency war fighting fund (Contingency Operation Fund) that is exempt from the Spending Caps. This would allow the Defense Department to cover routine military expenses with this funding. This action essentially “kicks the can down the road” and doesn’t solve the **SEQUESTRATION** dilemma. This is a contentious issue and the White House has threatened a veto.

The House version of the Defense Bill more closely aligns with MOAA’s position of not shifting costs on to the backs of our service members. The House rejected the administration’s proposals for Military Pay Caps, increased TRICARE fees, and higher out of pocket costs for Basic Housing. The Bill also provides a provision preventing The Defense Department from changing the Commissary and Exchange systems. The House however, did include provisions to **overhaul** the **Military Retirement System**. The Bill calls for combining the existing defined benefit 20 year vested plan with a portable retirement plan. The proposed change sets up Thrift Savings Plans (TSP), or Individual retirement savings accounts, for service members which they would own and keep, and allows them to receive government matching contributions. Government matching contributions would be available for service members beyond 20 years of service. This system would provide a retirement benefit for those members who do not reach 20 years of service, and now under the current system receives nothing. This proposal cuts the existing retirement annuity by about 20%.

The Senate has taken a different track in their version. The Senate does include a Pay Cap of 1.3%, or 1% below private sector growth whereas the House version did not. This would be the third consecutive year of Pay Caps. Unlike the House, the Senate has included major changes to Basic Housing Allowance. Depending on living arrangements and marital status reductions could vary from 5–20%. The Senate decided not to wait for additional studies for the Commissary and Exchange system to be concluded before acting. The Senate included provisions for change. The Senate Bill includes reductions for subsidies and includes a provision to launch a

pilot program for **privatization**. As in the House version, the Senate too included a provision in their Bill to overhaul the Military Retirement System. They too, call for a Hybrid system like the House, but unlike the House the Senate version stops government matching funds at 20 years. Stopping the matching funds at 20 years does little to nothing to provide an incentive to retain a strong NCO and Officer Corps in the Career Force.

The Senate version also seeks TRICARE changes which the House version did not. Several aspects of the proposed TRICARE changes were supported by MOAA but the Senate did include provisions to increase **TRICARE Prescription** fees. This is something that MOAA has been working to forestall. Unfortunately the Senate feels that Military families and retirees should do more. (Congress seems to know about sacrifice). Under the senate proposal, retail and mail order co-pays would double and triple over the next decade.

Like most legislation, differences exist between both chambers that will have to be reconciled. A tweak here or there or a major overhaul will be required. Both Bills will undergo modification in conference process between both the House and the Senate. What comes out of conference will then be voted on by both Chambers and the resulting Bill will be sent to the White House for approval.

The following is a brief comparison of Key items in the Defense Bills and MOAA’s position relative to each issue:

- Retirement:** Senate – Hybrid System, Gov’t contributions to TSP stops at 20 years  
 House – Same as Senate, Gov’t contributions to TSP to continue past 20 years  
 MOAA – Favor House version but need added study and Pentagon input
- Pay Raise:** Senate – Cap 2015 at 1.3%  
 House – Mirror Private Sector at 2.3%  
 MOAA – Favor House version
- TRICARE:** Senate – Increase retail and mail order pharmacy co-pays  
 House – No Changes  
 MOAA – Favor House version
- Commissary:** Senate – Cut funding and test privatization  
 House – No Changes  
 MOAA – Favor House version
- Housing:** Senate – Cut Allowances  
 House – No Change  
 MOAA – Favor House version

In other action on the Defense Bill, the House removed a provision that would have encouraged the Secretary of Defense to waive military enlistment requirements for illegal immigrants. It seems ironic that we would want to enlist illegals while we are eliminating American troops through the force draw down. The senate did not include a provision on immigration.

Several important veteran's bills have been introduced in this the 114<sup>th</sup> Congress, they are:

- Senate 1085: Military and Veteran Caregiver Services Improvement Act. This bill allows veterans of all eras eligible for the full range of caregiver support services through the VA.
- House 1141 and Senate 602: This bill allows members of the National Guard and Reserves to count time spent receiving care in a DoD facility for a line of duty illness or injury sustained during a call up to count as active duty for eligibility for GI Bill Benefits.
- Senate 1203: Veterans Benefits Delivery Act. This bill helps simplify and expedite the VA claims.

[http://www.moaa.org/Main\\_Menu/Take\\_Action/Take\\_Action.html](http://www.moaa.org/Main_Menu/Take_Action/Take_Action.html) MOAA has also provided suggested messages in support of these actions, and is encouraging us to send our legislators a message in support of these actions.

The Department of Defense's goal for FY2016 is to "slow the growth" through cutting military people programs. As shown above this activity is well on its way to being enacted. Where the final version ends up is anyone's guess, but what can be concluded is that **Military Retirement** will be changed. Change is the only constant in this process, but it seems fool hardy to affect the area most needed to have an effective force, trained and motivated soldiers. Cutting people programs is short sighted and is a detriment to recruiting and retention and will result in a less effective fighting force. MOAA continues to lobby for those programs that make sense and strengthen the military. Our voice is a part of this effort and we are encouraged to get involved. Contacting our representative either through MOAA's web site or individually can help in achieving a strong National Defense and keeping commitments to our veterans.
