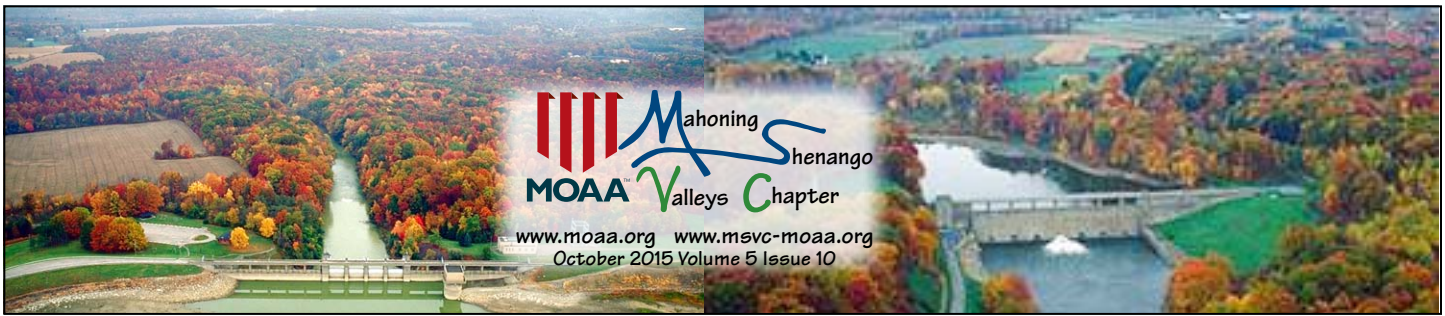

ROTC Program Today – Is So Different Than The Program We Experienced Years Ago

MAJ Robert Davidson, USA, Assistant Professor of Military Science at Kent State University and Youngstown State University was the guest speaker at our September Chapter Business meeting held at the Consolidated Activities Center of the Youngstown Air Reserve Station in Vienna. MAJ Davidson enlisted in the Army in 1995 as a Legal Specialist and received his OCS commission in the Military Police in April 2000. He received his Master's degree in Business and Organizational Security Management from Webster University, MO and his Bachelor's degree from Thiel College, PA. His many and varied assignments included tours in Korea, Germany, Fort Carson, CO and Fort Hood, TX and deployments for Operation Enduring Freedom and Operation Iraqi Freedom before coming to be the Assistant Professor of Military Science and primary instructor of MS-4 Cadets for Kent State and YSU in July 2014.

MAJ Davidson briefed approximately 30 members of the chapter on how the current ROTC program across the country has been restructured to meet the needs of the military. As sequestration and the on-going down-sizing of our military forces continues into the near future, the need for commissioned officers also continues to decline. This means that the ROTC program has become very competitive in the number of commissioning contracts available for junior and senior level cadets. Yet, despite the fewer number of slots available, Youngstown State has the largest recruiting class in over a decade with a total of 53 cadets. These include 29 MS-1 cadets, 17 MS-2 cadets, 3 MS-3 cadets, and 4 MS-4 cadets. The YSU ROTC program is a satellite program which operates out of Kent State University.

As MAJ Davidson explained, the ROTC program of today is much different than the program many of the present membership experienced many years ago. Today's Cadets are evaluated much more stringently for leadership qualities and academic excellence. Fifty percent of a cadet's evaluation is based on three standardized tests plus their overall GPA. Another 35% is based on the instructor's observations and evaluation of the cadet's performance, extracurricular activities, language proficiency, and cadet evaluations. The last 15% is based on their performance on their physical fitness test. This past summer YSU had four students attend the Cadet Leadership Training Course at Fort Knox, KY. This past year, over \$87,000 in scholarships were awarded to ROTC cadets, primarily to juniors and seniors who are contracted to be commissioned.

Reservists of C-123's To Receive Benefits From Agent Orange Exposure

Reservists who worked on C-123 transport planes after the Vietnam War soon could receive disability benefits and medical coverage for cancers and other illnesses related to exposure to Agent Orange.

It would affect up to 1,200 crew members who flew on or serviced C-123s after the war, when the planes were based at the 911th Airlift Wing in Pittsburgh, Rickenbacker Air Force Base in Columbus and Westover Air Reserve Station near Springfield, Mass.

Under the new rule, flight, medical and ground maintenance crew members who served on C-123s are presumed to have been exposed and for any reservist who is ill, the exposure is

presumed to have occurred while they were training, making them eligible for VA benefits including disability compensation, medical care, dependency benefits, indemnity compensation and burial.

The VA previously denied claims, saying the planes had been decontaminated and that the crew members didn't qualify for benefits anyway because they didn't serve in Vietnam and their disabilities didn't manifest during their military service.

- Must be 65 years old

- Must have served at least 90 days of active Federal duty with at least one day during a period of conflict.
- Must have a medical necessity requiring care
- Must meet income and countable asset criteria established by the VA

This may seem complicated or perhaps something that you personally will not qualify for, however, we probably all know Veterans or their surviving spouses who need assisted living but do not have the financial resources to manage this. Please take the time to become knowledgeable of this program.

Legislative Issues – October 2015

Legislative Affairs Co-Chair, COL John Koshan

Congress has once again dropped the ball. They have failed in their mission to pass a clean budget to fund the government for **Fiscal Year 2016**. Instead Congress has kicked the can down the road and have resorted to a **Continuing Resolution (CR)** to fund the government into December of this year. This CR funds the government at current levels and delays any solutions on some contentious issues until December. In my opinion look for another CR around *Christmas time*.

There is some good news however, in that the House and Senate conferees have reached agreement on a **\$612 billion** defense policy spending bill that the president has threatened to **veto**. The bill gives the administration the increase in funding requested but did so by using a war fighting account that is not subject to **Sequestration**. The administration has objected to this approach and is pushing to eliminate all sequestration requirements.

The following is a brief outline of the provisions contained within the **Annual Defense Bill**:

Military Pay: The bill **Caps** the active duty pay raise at 1.3%. This marks the third consecutive year of Pay Caps and continues to increase the wage gap between Military and the private sector compensation.

Military Retirement: The Bill includes major changes to the military retirement system. Beginning in January 2018 the Force will have a much different retirement than the **20 year or bust plan**. The defined benefit for serving 20 or more years will be cut by 20%. But a new **Blended Plan** will have new features including a **Thrift Savings Plan (TSP)**. This plan will have an automatic government contribution of 1% to the TSP with an additional match of up to 4% of a service member contributions. Essentially the government will match up to 5% of a service member's savings. This contribution will continue for up to **26 years of service**. The new plan also allows for a lump sum distribution of a portion of retired pay prior to Social Security eligibility. The new plan also provides for continuation pay i.e., payment at 12 years of service for those who agree to serve 4 more years. This provision will apply to both active and reserves. Additionally the new **TSP** accounts will be fully vested at two years and can be rolled into civilian employer 401K's, thus the issue of portability.

TRICARE: Congress has rejected the proposed major changes of means testing, higher enrollment fees and major consolidation efforts that were requested by the administration. Although no major changes were enacted, the Military Health Care system remains on alert for major re-evaluation. Increased prescription co-pays however, have been included in the bill. A compromise was reached on this issue and a one year increase was proposed. Increases range anywhere from 6% to 20% depending on retail or mail order. The MOAA web site contains a chart detailing the final proposals on these increases.

Commissaries: The original budget proposals called for a consolidation of the commissary and exchange with significant funding cuts to the commissary. Congress has rejected DoD's proposal and instead provided DoD with new authorities to test ways to operate stores more efficiently including varied pricing schemes and evaluating the idea of privatization.

For all the compromise to control personnel costs, the president vows to veto the bill over how the congress has skirted **the Budget Control Act or Sequestration**. Rather than repeal or renegotiate the debt reduction act, which would better protect defense accounts, congress inserted \$\$ into the Overseas Contingency Operations account which is exempt from Sequestration. A long and contentious fight is about to begin, grab a chair and observe.

MOAA has expressed their disappointment in the final Defense Bill and its adverse effects on the military. MOAA's opinion is that slashing Military retirement and providing a 401K style retirement will erode recruiting and retention and may provide more incentive for members to leave the service early. This bill sets new policy to **Vest** retirement by imposing major cutbacks to retirement
