



LTC John Caparanis was the luncheon speaker for January

One of the largest attended luncheon meetings in recent Chapter history gathered at the Consolidated Activities Center (CAC) of the Youngstown Air Reserve Station (YARS) on Friday, January 25th to hear the inimitable radio voice of Trumbull County high school football and basketball, LTC John Caparanis, as he spoke to a mesmerized audience of 52 Chapter members. Caparanis, whose local radio broadcasting career began in the early YSU coaching days of Jim Tressel, also excelled in cable television sports broadcasting and starred in his own sports talk show called “Tip of the Cap.” He is one of the preeminent radio personalities in the area still broadcasting high school football and basketball games to this day.

While at Ohio University he was tutored by legendary Cleveland Cavaliers announcer, Joe Tait. Upon graduation in 1968, John received an Army commission in the Signal Corps and was sent to Dugway Proving Grounds in Utah where they test chemical and biological weapons. There he gave classes on top secret weapons orientation courses to FBI, CIA, and NATO military personnel utilizing state-of-the-art audio-video equipment. After a stint in Viet Nam as a communications evaluator his active duty obligation came to a screeching halt when the Army would not acquiesce to a re-enlistment in the

Armed Forces radio. But, following his Dad, a Silver Star recipient during World War II, John’s sense of duty carried him to serve in the Army Reserves. So, from 1971 to 1995 LTC Caparanis served with the 660th Transportation Co. in Cadiz, the 1036th USAR School in Farrell, PA, the 475th QM Petroleum Group in Farrell, PA, and the 1036th USAR School in Cleveland. He was activated during Desert Storm on January 21, 1991 and sent to Fort Gordon to again teach about chemical and biological weapons.

During the riveting presentation, John mentioned a few of the more interesting highlights of his sports broadcasting career including interviews with famous professional athletes and other major sports announcers. Among the best interviews he had was with Joe Garagiola while perhaps the most embarrassing interview was with Gaylord Perry when he asked the future Hall of Famer who at the time had 298 career wins, “Gaylord, when will you get your 300th win?” Gaylord tells John without hesitation. “I can tell you EXACTLY when I will win game number 300. The win right after my 299th!!” John estimates that he has broadcast over 1500 basketball games and over 1000 football games – TV and radio combined. This included a high school basketball game when Poland played Akron St. Vincent—St. Mary in a State Tournament game where LeBron James simply overwhelmed the Bulldogs. John has had the privilege to meet, know, and interview many famous sports personalities throughout the years from football players attending a USO event in Viet Nam to players like Bob Feller at a sports banquet. To the attentive audience, John’s stories brought a fresh and very interesting perspective on a career spanning over 50 years.

Hosler. Mrs. Shirley Caparanis won the book, “The First Frontier. The Forgotten History of Struggle, Savagery, and Endurance in Early America” by Scott Weidensaul. Legislative Issues and Actions LTC Rod Hosler, USA, Ret

Federal Legislation—Bipartisan House Bill Would End ‘Widow’s Tax’

Legislation introduced by Reps. Joe Wilson (R-S.C.) and John Yarmuth (D-Ky.) would end the deduction of Survivor Benefit Plan (SBP) annuities from Dependency and Indemnity Compensation (DIC) paid to survivors of fallen service members, known as the “widow’s tax.”

MOAA has long supported repeal of the widow’s tax, backing similar legislation from Wilson and others. The change would mean that in cases where military service led to the death of a servicemember, DIC would be paid in addition to the SBP annuity.

About 67,000 military survivors would benefit from this legislation, with the current offset costing them about \$12,000 annually.

“The SBP-DIC offset remains grossly unfair to the members of the military community who deserve our support the most,” said Lt. Gen. Dana T. Atkins, USAF (Ret), President and CEO of MOAA. “We thank Reps. Wilson and Yarmuth for their bipartisan leadership on this issue, and we encourage their fellow legislators to join the fight.”

“This is uniformly agreed-upon throughout Congress, but they haven’t found the political will to resolve it,” Atkins said. “The 116th Congress has an opportunity for getting this done.”

Wilson introduced the new legislation — **H.R. 553**, the Military Surviving Spouses Equity Act — on Jan. 15, with Yarmuth as the bill’s lone listed original co-sponsor. Text of the bill wasn’t immediately available, but it’s essentially similar to bills Wilson introduced in the last four congressional sessions, with all four bills garnering more than 200 co-sponsors. Despite the support, neither these bills nor similar ones put forward by other legislators in previous sessions were put up for a vote, even by a committee.

“It is unconscionable to think there is a ‘Widows Tax’ on the surviving family members of our fallen heroes,” Wilson said in a release announcing the bill. “We owe it to them to secure stable benefits in the event of their retirement or death.”

Yarmuth, the newly installed chairman of the House Budget Committee, echoed that statement saying the bill “corrects a terrible wrong and makes clear that we support members of our military not just when we need them, but when their families need us.”

In April, as part of its annual Storming the Hill event, MOAA plans to bring in chapter leaders from across the country to meet with lawmakers to find a permanent end to the widow’s tax.

Federal Legislation—Blue Water Navy Veterans Must Receive VA Healthcare

On Tuesday, 29 January, a federal appeals court in Washington sided with thousands of U.S. Navy Vietnam War veterans who were stationed offshore during the war and developed health problems linked to exposure to the toxic herbicide Agent Orange.

The U.S. Court of Appeals for the Federal Circuit ruled overwhelmingly for these sailors, finding they are eligible for the same disability benefits as those who put boots on the ground or patrolled Vietnam’s inland rivers.

The 9-to-2 decision reverses a decade-old ruling by the court and applies to an estimated 52,000 veterans nationwide. A court majority said Congress clearly intended to extend benefits to sailors who were stationed in the territorial seas and are known as “blue water” Navy veterans.

“We find no merit in the government’s arguments to the contrary,” Judge Kimberly A. Moore wrote for the majority.

Key Ohio Bills—HB 158: PASSED—Allow for unemployment compensation for trailing military spouses if they depart the state due to transfer orders. **HB 716: Passed House Only** - Granted a temporary license or certificates to members of the military and their spouses who hold an occupational license in another state or jurisdiction and subsequently move to the state of Ohio. **HB 351: Passed House only** —Required municipalities to tax exempt pay of NOAA and PHS members. **HB 603: Passed House only** - Granted residency status for all members of the military, their spouses and dependent child for the purpose of “in-state-tuition.” **HB 523: Passed House only** - Require civilian authorities to identify and report all military family abuse and/or violence situations to appropriate military representatives.

Must See At Your Local Theater **They Shall Not Grow Old**

They Shall Not Grow Old is a 2018 documentary film directed and produced by Peter Jackson. The film was created using original footage of World War I from the British Imperial War Museum's archives, most of it previously unseen, alongside audio from BBC and IWM interviews of British servicemen who fought in the conflict. Much of the footage has been colorized and transformed with modern production techniques, with the addition of sound effects and voice acting to be more evocative and feel closer to the soldiers' actual experiences.

Lasting 90 minutes, the film is an immersive experience of "what it was like to be a soldier" rather than a story or a recount of events. Jackson's crew reviewed 600 hours of interviews from 200 veterans, and 100 hours of original film footage to make this film. I believe it surpasses Ken Burn's Civil War in style, that tells the story of the soldier in World War I. It is a must-see film, so don't miss it.

It will play to the end of the week (may stay longer) at Regal Cinemas South 10 in Boardman, and Regal Cinemas Interstate Park 18, Eastwood Mall, Niles and can be view three times daily. Check local listings.
