# MSVC/ROA Team Up for Decoration of the Graves

After a highly successful 2021 Cadet Night in late April, Mahoning and Shenango Valleys Chapter-Military Officers Association of America (MSVC-MOAA) and Reserve Organizations of America/Chapter 42 (ROA/42) teamed up again to honor deceased veterans by decorating their graves Saturday, May 15, which coincided this year with Armed Forces Day

Led by chapter presidents Rod Hosler (MSVC-MOAA) and Walt Duzzny (ROA/42), six members placed over 150 U.S. Flags on veterans' graves at Calvary Cemetery in Youngstown. The tradition has been held annually, rain or shine, for over twenty years, with MSVC joining the effort with its establishment ten years ago.

Established in 1885, Calvary Cemetery stretches over 150 acres and is owned and operated by the Roman Catholic Diocese of Youngstown. The cemetery is home



to the graves of dozens of veterans, including former Sandusky, OH native Leonard Thom, Executive Officer, PT-109, who survived his ship's collision with a Japanese destroyer in World War II and died in a car crash in 1946 in Ravenna, OH.

With many if not most local Memorial Day observances still being cancelled due to pandemic concerns, MSVC and ROA continue to do their part to recognize veterans and honor their service.

S. B. No. 160 A B I L L To amend sections 173.42, 3712.06, and 3727.75 and to enact section 3721.141 of the Revised Code to require certain entities to inform veterans about available health care benefits and to name this act the Veteran Information Act. Still in hearings.

H. B. No. 29 2021-2022 A B I L L To amend sections 317.24 and 317.241 of the Revised Code to allow a person who was discharged from the United States Public Health Service or the National Oceanic and Atmospheric Administration to obtain an Ohio veterans identification card. As passed by the House. Forwarded to the State Senate for action.



#### Pennsylvania

There are several bills before the <u>General Assembly</u> pertaining to veterans housing, homelessness and Veteran's Affairs funding.

There are several House and Senate bills before the assembly to abolish "no excuse" mail-in ballots. Senate Bill 402
