MSVC Hears Iraq Deployment Brief

At its November 19 Lunch Meeting, Mahoning and Shenango Valleys Chapter-Military Officers Association of America (MSVC-MOAA) heard from one of its own members on his 2020-2021 deployment to Iraq.

With 29 members and one guest in attendance, Chief Warrant Officer (CW) 2 Nathan ("Nate") Walker, Ohio National Guard, discussed his deployment to Erbil, Iraq as an Army aviator flying the Boeing CH-47 CHINOOK helicopter with Bravo Company, 3 Battalion, 238th Aviation Regiment based in North Canton, Ohio.

According to Nate, half of his company of twelve aircraft remained in the northern part of Iraq flying out of Erbil International Airport, while the rest deployed to southern Iraq. His company logged over 1100 flight hours, hauling 1.3 million pounds of cargo and nearly 5000 passengers in Iraq and eastern Syria. They also set up Forward Arming and Refueling Points (FARP's) for ground forces and other aviation units, directly transported combat forces, and performed aircraft recoveries.

Nate explained that the CH-47 CHINOOK helicopter is well suited to this role, with a 50,000lbs maximum gross takeoff weight, provisions for up to 33 passengers, and additional internal fuel tanks for FARP's.

MSVC also welcomed YSU Army ROTC Cadet Zackary Swantek as a guest. The senior class cadet, who hopes to join the Aviation Branch upon graduation/ commissioning next spring, hails from Springfield, Ohio and is majoring in Criminal Justice. Best wishes to you, Zack!



Budget Delays May Cost DoD More Than \$40 Billion. Ask Your Lawmakers to Act

As the government-wide stopgap funding measure known as a continuing resolution (CR) nears its Dec. 3 expiration, there have been a few encouraging signs. But all optimism could be dashed if Congress doesn't act fast.

CRs occur when Congress doesn't meet its own schedule for funding the federal government. This scheduling delay is wasteful and calamitous for those in uniform and costs taxpayers billions of dollars (more on that later). During a CR:

- Planned training exercises, official travel, and hiring actions are often halted.
- Obsolete programs no longer needed continue to be funded at last year's rate.
- New programs are put on hold and can incur dramatic cost increases because of the delays.
- Short-term CR deadlines take precedence over long-term planning, and the entire federal government operates under the threat of a shutdown.

Three months into the new fiscal year with no funding is unsatisfactory, and MOAA urges Congress to stop this wasteful trend.

The president signed legislation Sept. 30 to avoid a government shutdown; the chamber votes indicate movement off the middle, with the House passing the measure 254-175 and the Senate approving it 65-35. This level of support for a temporary solution is somewhat encouraging, and it sets up a variety of potential near-term outcomes.

Second, if the show of support holds, this could parlay into more comprehensive efforts toward full appropriations – or at least to get the ball rolling on the appropriations bills still stuck in Congress. But it would take exceptional commitments from both sides to have a chance on making headway toward full appropriations.

A third outcome would be some combination the first two -- another continuing resolution, but with the promise of getting together to finish up appropriations at the beginning of the new year.

<u>H. B. No. 407</u> Establish the Safe Shelter Initiative Program for Ohio veterans

<u>H. R. No. 104</u> To recognize the brave men and women of the United States Armed Forces who served in Afghanistan, and to urge the United States Congress to investigate failures that led to the collapse of the government of Afghanistan.

S. B. No. 160 A B I L L To amend sections 173.42, 3712.06, and 3727.75 and to enact section 3721.141 of the Revised Code to require certain entities to inform veterans about available health care benefits and to name this act the Veteran Information Act. Has been referred to the Judiciary Committee, 6/19/21

H. B. No. 29 2021-2022 A B I L L To amend sections 317.24 and 317.241 of the Revised Code to allow a person who was discharged from the United States Public Health Service or the National Oceanic and Atmospheric Administration to obtain an Ohio veterans identification card. State Senate amendments refused by the House. 6/28/21

Surviving Spouse Corner: What to Expect in 2022 With the 'Widows Tax' Repeal

We are coming up on the second year of a three-year phase out of what has been known as the "widows tax," which required forfeiture of a dollar of Survivor Benefit Plan (SBP) for every dollar of Dependency and Indemnity Compensation (DIC) received. Please note this is only applicable to those surviving spouses who qualify for both DIC and SBP and are in receipt of the Special Survivor Indemnity Allowance (SSIA).

NEW ID CARD REQUIREMENTS

DOD is instituting a new ID Card procedures. If you are an active, reserve component officer, retired officer or dependent and your military ID Card has **EXPIRED**, and you haven't been able to get it renewed because of COVID-19 closures, you have until the end of January 2022 to get it renewed. Failure to do so may impact your TRICARE and other military benefits. Currently all ID facilities in the area are booked up for several months at least through February. You can go online to log onto the Rapids locator https://idco.dmdc.osd.mil/idco/ to schedule your ID card appointment. I have contacted Lt. Gen. Atkins, the MOAA CEO and he and his staff is working this issue with DOD to extend the date.

Historical Anecdote.

The Air Force unveiled the latest air-ground tactical support aircraft. Department of the Air Force reported, "We'll dominate the battlefield with this high-tech weapons platform." This technology will save the Air Force approximately \$35 million per aircraft. However, some defense experts express skepticism on mission survivability of pilot, crew and aircraft with Congressional cost savings measures that eliminate radio communications, armor plating protection, engine upgrade, parachutes and wind shield. Addition of wheels and landing gear is a positive step.
