There are a variety of rules and regulations governing the wear of military uniforms. Each branch of service has a manual that dictates the wear, use, and maintenance of that service's uniform items. There are references to allowed and disallowed wear of uniform items in the Uniform Code of Military Justice, and there are even rules for uniform wear in the United States Code.

## Common Rules For Wear Of The Uniform As A Veteran OR As A Retiree

Some common rules for wear of the uniform apply to all regardless of status. You cannot wear your military uniform:

In connection with political or commercial interests

During off-duty civilian employment

At public speeches, interviews, picket lines, marches, rallies, or public demonstrations, "except as authorized by competent authority"

Any situation where wearing the uniform "would bring discredit upon the Uniformed Services"

When "specifically prohibited" by DoD Regulations

In criminal or civil court

At any event deemed to be "anti-government in nature"

There are additional restrictions. You cannot wear a battle dress uniform to a formal event, for example. The uniform worn must be appropriate to the event. The wearer must have insignia, rank, medals and ribbons, etc. that were either current at the time of military discharge (retirement or separation) OR which are current now. You cannot mix and match.

#### **Wearing The Uniform As A Military Retiree**

Military retirees—those who served for 20 years or more and receive or are eligible to receive military retirement pay—are permitted to wear their uniforms in more circumstances than those who separated from military service but did not reach the qualifying number of years of duty to draw retirement pay.

For the purposes of these rules, anyone medically retired qualifies as a military retiree.

## **Wearing The Uniform As A Veteran**

Veterans are described as military members who served but did not accumulate 20 years of service. These troops separate from military service but do not draw retirement pay.

Wearing a uniform as a veteran is technically only permitted during special occasions "typically centered around military service and family events" including military funerals, military weddings, etc. Military-themed holiday events such as the 4th of July may also be appropriate for uniform wear as long as the events don't violate other guidelines associated with political speech, employment, etc.

The same wear of the uniform rules mentioned above apply including the prohibition on mixing and matching uniform items which are current and/or those worn at the time of separation.

#### **Grooming Standards While In Uniform As A Retiree/Veteran**

Obviously those who wear the uniform after retirement or separation cannot be forced to maintain the same grooming standards including weight, haircut and color, jewelry, fingernails, accessories, etc. as active duty troops. That said, it's considered a standard part of military customs and courtesies to apply the same grooming standards to non-active duty/retired/separated uniform wear as when the veteran or retiree served.

January 2022

There are many legislative take action alerts on the MOAA website at https://takeaction.moaa.org/ moaa/ The featured alerts and articles are the same ones listed as last month. The highlighted headline is entitled "Ask Your Legislators to Adjust SGLI and VGLI for Inflation With the Supporting Families of the Fallen Act". I would encourage everyone to go to the following site and take action by contacting Congress using the drafted message. Here is more information on this alert: "Service members' Group Life Insurance (SGLI) and Veterans' Group Life Insurance (VGLI) coverage amounts have not been updated since 2005. This law would raise the level from \$400,000 to \$500,000 – a necessary move to preserve the value of this program in the face inflation. Ask your lawmakers to lend their support today." A few of the other issues include, "Support Health Care for Children of Disabled Veterans or Veterans Who Have Died Due to a Service-Connected Disability", "Urge Your Senators to Support Legislation Extending TRICARE Coverage to Certain 'Gray Area' Retirees", "Urge Your Senators to Support Legislation to Repeal the TRICARE Select Enrollment Fee", and "Ask Your Lawmakers to Support the Military Retiree Survivor Comfort Act". From the take action page, you have to enter your zip code and then it will take you to the draft correspondence. Enter your name, address, and POC information and follow the simple directions to send the correspondence. The entire process takes about two minutes.

There are also 25 key bills that MOAA is supporting listed on the Take Action page (link above). This is a great list if you're interested in learning more about the bills. You can click on the name of the bill and learn more about it.



## **LEGISLATIVE ISSUES**



#### OHIO

S. B. No. 160 A B I L L To amend sections 173.42, 3712.06, and 3727.75 and to enact section 3721.141 of the Revised Code to require certain entities to inform veterans about available health care benefits and to name this act the Veteran Information Act. Passed by Senate, referred to committee.

H. B. No. 29 2021-2022 A B I L L To amend sections 317.24 and 317.241 of the Revised Code to allow a person who was discharged from the United States Public Health Service or the National Oceanic and Atmospheric Administration to obtain an Ohio veterans identification card. House and Senate Conference reports agreed to: Effective 3/23/22

#### Pennsylvania



There are several bills before the <u>General Assembly</u> pertaining to veterans housing, homelessness and Veteran's Affairs funding.

House Resolution 129 P.N. 2003 A Concurrent Resolution establishing the Task

Force on Women Veterans' Health Care in the Commonwealth of Pennsylvania.

<u>House Bill 688 P.N. 646</u> An Act establishing the Veterans' Housing Assistance Program; and making appropriations.

# YOUR MEDICARE PART B RATES WILL SPIKE IN 2022. HERE'S WHAT YOU'LL PAY

Medicare Part B premiums will rise by the highest level in the program's history next year, with most Part B users paying 14.5% more than they did in 2021.

The Standard Part B 2022 premium of \$170.10 is up from \$148.50 in 2021. This is the monthly amount paid by beneficiaries who had a modified gross adjustment income of \$91,000 or less on their 2020 individual tax return or \$182,000 or less on a 2020 joint return.

The increase dwarfs last year's 2.7% standard rate of hike. A Centers for Medicare and Medicaid Services (CMS) fact sheet offers three main reasons for the increase: Rising health care prices and utilization as patients return to provider offices for routine care while COVID-related expenses persist, a \$4-permonth increase brought about by legislative fix that

lessened last year's increase during the COVID-19 pandemic, and uncertainty regarding costs and coverage of Aduhelm, a new Alzheimer's medication. More information can be seen at the MOAA website.


