MOAA Resources: Spouse and Family

Senators Pressure DoD to Expand Housing Review After Investigation

A bipartisan pair of senators is calling for the Pentagon to expand a review of military housing owned by Balfour Beatty Communities following the lawmakers' own scathing investigation that found the company continues to ignore residents' concerns about hazardous living conditions.

The Army already announced a new probe in response to the recent report from the Senate Permanent Subcommittee on Investigations, or PSI, and a subsequent hearing the subcommittee held about its report.

Now, the leaders of that subcommittee are pressing the Pentagon to expand the probe to the Navy and Air Force.

"Balfour pled guilty to fraud against all three military service branches -- the Air Force and the Navy as well as the Army," Sens. Jon Ossoff, D-Ga., and Ron Johnson, R-Wis., wrote in a letter Friday to Defense Secretary Lloyd Austin.

"Further, the information uncovered by PSI's inquiry and at the April 26th hearing suggests that Balfour has continued to mistreat military families and to record inaccurate and incomplete work order data in its internal Yardi system at non-Army installations," added Ossoff and Johnson, the chairman and ranking member of the subcommittee, respectively.

LEGISLATIVE ISSUES : ADVOCACY IN ACTION

LEGISLATIVE AFFAIRS – Rod Hosler

MOAA continues to actively advocate for legislation to better the condition of Americas military and their families. The key items that MOAA continues to address this year are: 1.) Concurrent Receipt for Combat Injured Service Members (Major Richard Star Act); 2.) Tricare Mental Health Copayments; and 3.) Military Pay Raise at 4.6% for the 2023 National Defense Authorization Act (NDAA). Progress is being made but it is a slow process. Many Congressional Representatives still have to come on board to cosponsor the legislation.

There are other legislative issues are being considered and are in committee and MOAA continues to monitor their progress as well. The MOAA's legislative priorities and other issues can be found at the legislative take action alerts on the MOAA website at https://takeaction.moaa.org/moaa/

MOAA National continues to ask its members to take note of the issues at their Legislative Action Center and on the individual "Take Action" email messages. Continue reaching out to your lawmakers on these issues, as well as track what MOAA is engaging on in the halls of Congress.

VA Clinic Named After A Living Chapter Member

The Veterans Affairs Ohio Healthcare System dedicated the new Carl Nunziato VA clinic in Youngstown, Ohio, on Armed Forces day 2022. What made this dedication so distinctive was that it was dedicated to a living individual. When the VA approved the construction of the new clinic, a contingent that was led by two purple heart veterans, Herman Breuer and Leo Connelly, also Congressman Tim Ryan (OH-13.) Ryan introduced legislation in November 2019 that names the Department of Veterans Affairs community-based outpatient clinic in Youngstown, Ohio the "Carl Nunziato VA Clinic." The clinic opened in January of 2021 but due to the pandemic the dedication was de-layed.

Carl Nunziato was born in Youngstown, Ohio in 1938, graduating from Rayen High School. After marrying his high school sweetheart, Clara, he attended college at Youngstown State University. Through the university's Reserve Officer Training Corps program, Carl earned a commission as a 2nd Lieutenant in the United States Army and served three tours in Thailand and Vietnam. On November 22nd, 1966, Carl lost both of his legs when an enemy mortar round impacted less than 3 feet away from him as he was running toward his unit's command center. He spent 23 months at Walter Reed Army Hospital recovering. Nunziato retired from service in 1968 and among his awards are the Bronze Star, the Purple Heart, Army Air Medal, and the National Defense Medal.

Carl returned home to Youngstown, enrolled in law school at Case Western Reserve, and with graduation began yet another battle: the fight for veterans, and all Americans, with disabilities. As an attorney utilizing a wheelchair in 1970s, most of the courthouses he encountered lacked the accessibility he, and other Americans like him, needed to simply be able to get to his job. Carl saw the problem and seized the initiative, as he had always done with obstacles he encountered in life. He dedicated his life to serving his community, fellow Veterans, and fighting for the rights of disabled Veterans.

One need was for a VA clinic to serve 40,000 veterans in the area in the 1980's. Nunziato said the VA would send a nurse to Youngstown to see veterans in need of medical care, but it was literally a Band-Aid approach to treatment, and patients had to go to other VA facilities — the closest ones in Cleveland and Butler, Pa. — for actual treatment, which are 75 miles away. The old VA clinic opened in Youngstown in 1991. Thirty years later Carl was instrumental in getting the new, larger facility built. The closing comments at the dedication to Carl: "We may never be able to repay you for your sacrifices but we will do our best to honor your legacy by providing quality care wor-thy of your name to our community's veterans for generations to come."

After the ceremony, a painting of Nunziato by Ray Simon was unveiled. It is hung at the entrance for everyone entering the clinic to see.

Mahoning and Shenango Valleys Chapter of MOAA gave Carl a MOAA golf shirt to celebrate the occasion.
